## RELIGIOUS ETHICS 1 a & b RELIGIOUS AND THEOLOGICAL ETHICS

This examination requires students to demonstrate knowledge of the relationship between religion and morality throughout history. The focus is on major developments and core texts of the field of religious ethics. The list below is known as RETH 1a.

Students who wish to focus on a particular religious tradition not heavily featured on this list may, in consultation with their examiners, substitute approximately half of these texts with texts about religious and theological ethics from the tradition in question. This modified exam is known as RETH 1b.
